The LEED AP+ BD&C replaces the LEED AP for New Construction exam track. This BD & C specialty provides a standard for professionals participating in the design and construction phases of high-performance, healthful, durable, affordable, and environmentally sound commercial, institutional, and high-rise residential buildings. The AP+ BD&C is now designated a Tier 2 Accreditation.

## ABOUT THIS ONLINE COURSE

## WHO SHOULD ATTEND AND WHY?

The LEED AP+ BD&C Specialty Exam is for those professionals that implement on LEED projects. You have to pass the LEED Green Associate exam first (or in conjunction with). Additionally, in order to take this LEED specialty exam, you need to have worked on a LEED registered or certified project\*. If you have access to the LEED v3 BD&C Reference Guide, that will help while following along with this course.
