

## Advocacy Report 06/06/2025

The Building Chapter's Legislative Team met on Friday, January 31 to review bills for the 2025 Legislative session.

Sheila is a member of the Nebraska Economic Developers Association, Nebraska State Chamber's Public Policy Committee and University of Nebraska Advocacy Group. She regularly attends their legislative meetings to listen to and provide input on bills of importance for our industry, economic development and Nebraska's business climate.

## Nebraska Legislature adjourned Sine Die on June 2 for the 2025 session.

This concludes the first year of a two-year biennium. During the 89-day session, 715 bills were introduced, and 18 Constitutional Amendments were proposed. 209 bills were sent to the Governor, with 113 more bills packaged and passed as amendments, bringing the total number closer to 320 introduced bills becoming law. Two bills were vetoed, and one constitutional amendment was sent to the Secretary of State for the voters to determine whether legislators will be allowed to serve three consecutive terms, rather than the two four-year terms now allowed.

The first year of a two-year session is always headlined by the adoption of the State's biennium budget. The Legislature this year completed that Constitutionally-required work on day 80 of the Legislative session – adopting an \$11 billion budget. Most notably on the budget action was the Governor's attempted line-item vetoes of \$14.5 million in General Fund appropriations and \$18 million in cash fund diversions that were untimely and incorrectly filed, resulting in the Legislature's budget bills becoming law as passed by the Legislature, including the appropriations intended to be vetoed.

The second session of the 109th Legislature will begin on January 7, 2026. There are 60 legislative days scheduled for the second year of the biennial session.
